Every step in the development of this guide was based on open dialogue with members of the queer refugee community, so that the information provided is practical, clear and tailored to your realities.

We want these pages to give you not only practical support, but also a sense of belonging and solidarity. Whatever difficulties you face, you are not alone. We are here with you.

# Why this guide?

We have created this guide because **we know** from our own experience how difficult it can be to find clear information, to feel understood and accepted. LGBTIQ+ refugees face specific challenges, such as discrimination, lack of information and integration difficulties, and sometimes barriers to access services and support.

In the following pages you will find the information you need to feel safe and supported in your new beginning in Moldova, including:

- How to find legal support and navigate the documentation system.
- Safe places where you will be accepted as you are.
- Friendly resources for health, housing and mental health support.
- Tips for integrating and building a new community.

Each line in this guide reflects the experiences and perspectives of queer refugees who have contributed to its development. We hope that these pages will give you **the support you need** and remind you that, no matter what your struggles, you are not alone.

**This guide is about you,** created with empathy and practical thinking so that you can find the resources you need quickly and without obstacles.

# Section 1:

# Legal Documentation: How to get protection in Moldova

Starting a new chapter in life can be overwhelming, especially when it comes to understanding the **laws** and **procedures** in a new country.

This section is designed to guide you **step-by-step** through the process of accessing legal protection in Moldova, whether you want to apply for refugee status or temporary protection. Everything is free and the authorities are there to support you.

# Step-by-Step Guide to Applying for Asylum in Moldova

# Step 1: Determine Your Eligibility

To qualify for asylum, you must be fleeing persecution, conflict, or other serious risks in your home country. The Moldovan government ensures asylum is accessible to anyone who requires international protection.

# Step 2: Where to Apply

You can submit your asylum application at any of the following locations:

- 1. The **General Inspectorate for Migration** (GIM) offices.
- 2. Border crossing points upon entering Moldova.
- 3. Police stations in Moldova.
- 4. Detention centers and penitentiaries, if applicable.

**Important Note:** Applications for asylum must be filed within the territory of Moldova. It is not possible to apply for asylum from abroad.

# Step 3: Declare Your Intent to Seek Asylum

To initiate the asylum process:

- 1. Clearly express your intention to seek protection to the authorities. This can be done verbally or in writing.
- 2. You do not need to provide a complete set of documents at this stage. The Moldovan authorities are required to accept and process your application based on your declaration of intent.

# Step 4: Complete the Application Form

Once you have declared your intention, you will need to:

- 1. Fill out the official application form provided by the authorities.
- 2. Submit your application form to the relevant office where you initiated the process.

If you submitted your application at the border or in another location other than the GIM headquarters, you will be accompanied by GIM to their office, where you will receive the temporary asylum seeker identity document. This document confirms your status as an asylum seeker and will serve as your primary identification during the processing period.

# **Step 5:** Temporary Surrender of Travel/Identity Documents As part of the process:

- You will need to surrender your original travel and identity documents to the authorities.
- If you need your documents temporarily for specific purposes (e.g., legal matters, travel within Moldova), you can request them in writing.

# Step 6: Attend Your Interview

After submitting your application, the Asylum and Integration Directorate will:

- 1. Schedule an interview to review your case in detail.
- 2. Assess your claim based on the evidence and your statements.

### Step 7: Receive a Decision

Once your application has been reviewed:

- If you are granted refugee status, you will receive an identity card valid for five years.
- If you are granted humanitarian protection, your identity card will be valid for three years.
- If your application is denied, you will be informed of the reasons and required to leave Moldova. However, you have the right to appeal the decision within 30 days.

The time limit for processing an asylum application is **up to six months**. If a decision cannot be made within this timeframe due to reasons beyond the control of the Asylum and Integration Directorate, the deadline may be extended, provided that the necessary steps are taken to reach a decision.

**The entire process is free of charge**. You must comply with Moldovan legislation throughout the procedure.

# **Temporary Protection for Ukrainian Nationals**

If you have been displaced due to the war in Ukraine, Moldova offers temporary protection. This is a fast-track procedure designed to grant essential rights and services.

# **Eligibility for Temporary Protection**

You can apply if you meet any of the following criteria:

- Ukrainian citizen.
- Stateless person recognized as such in Ukraine before 24 February 2022.
- National of a third country who received international or national protection in Ukraine before 24 February 2022, and cannot safely return home.
- Family members of any of the above individuals.

# **Steps to Apply for Temporary Protection**

- **1. Register Online:** Visit <u>TemporaryProtection</u> to provide personal information, upload necessary documents, and schedule an appointment.
- **2. Attend the Appointment:** Bring your original identity documents and attend your scheduled meeting at the selected office of the General Inspectorate for Migration.
- **3. Receive Your Temporary Protection Document**: After a brief interview, you will receive a temporary protection document granting you rights in Moldova.

# **Benefits of Temporary Protection**

- 1. Right to live and work in Moldova.
- 2. Access to healthcare, education, and other social services.
- 3. A defined period of legal stay and protection in Moldova.

Now you are fully prepared to begin your asylum or temporary protection application in Moldova. If you have any questions or require assistance, <u>Help UNHCR Moldova</u>, <u>Law Centre for Advocates (CDA)</u>, <u>GENDERDOC-M</u> and <u>Refugee Charity Centre (CCR)</u> are available to help.

# Section 2:

# Cash assistance for refugees in Moldova

Cash assistance is a flexible way to meet your specific needs, allowing you to decide how to allocate resources based on your unique circumstances. Moldova provides this support through Cash Enrolment Centres operated by UNHCR and its partners.

# **How Does Cash Assistance Work?**

New refugees arriving from Ukraine to Moldova will receive two months of initial cash assistance. After this period, Refugees will need to demonstrate a more secure legal status in the country and meet the new vulnerability criteria. During the interview, we will ask you a series of questions to gain a deeper understanding of your needs and capacities as they relate to household composition, accommodation, health, socio-economic status, and specific needs.

This information is vital in assessing your eligibility for cash assistance. Please note that all the information collected during these interviews will be kept confidential.

Trained staff from the cash enrolment centre's Protection Desks will provide a safe and confidential space for discussing sensitive information. LGBTQI+ refugees can disclose specific needs confidentially to ensure appropriate support.

# The following are recognised as legal statuses in Moldova:

- Temporary protection
- Refugee status
- Humanitarian protection
- · Asylum-seekers
- Stateless status
- Residence permit (either temporary or permanent)

# What does the cash assistance cover?

- Purchasing food, clothing, or hygiene products.
- Paying rent or securing temporary accommodation.
- Accessing healthcare or transportation.

# What are the steps for the enrolment process?

Step 1: Visit the nearest Cash Enrolment Centre.

Step 2: Bring your essential documents, such as identity documents provided by the Government of Moldova (Temporary protection ID, asylum-seeker certificate, refugee status beneficiary ID, stateless status ID, stateless applicant certificate, humanitarian protection ID, residence permit) national passport, national ID card, medical reports (if any), disability certificate (even if expired)

# Step 3: Complete the enrolment form with the help of trained staff.

Remember that if you have any problems or are going through a difficult situation, you can always approach one of our Protection Desks, located at the Cash Enrolment Centres.

Cash Enrolment Centres are open from **9:00 am - 5:00 pm**, from Monday to Friday.

# **Confidentiality and Safety**

All enrolment processes prioritise your privacy. Trained staff are sensitive to the unique needs of LGBTQ+ refugees and will ensure your information is handled securely.

Section 3:

# Shelter or Temporary Housing

**GENDERDOC-M** provides shelter services for LGBTQ+ refugees in Moldova, a safe and supportive environment. This service is available to all refugees, independently of their nationality.

# **How to Access Shelter Services**

# 1. Contact the LGBTQ+ Refugee Hotline

The 24/7 LGBTQ+ Refugee Hotline is the primary point of contact for accessing shelter services. Refugees can call +373 604 91 200 or use platforms such as Telegram, Viber, WhatsApp, or Signal to request assistance.

### 2. Visit the GENDERDOC-M Office

Refugees can visit the GENDERDOC-M office directly to arrange accommodation. Upon arrival, a stay contract will be prepared, ensuring a smooth and secure process.

### 3. Personalised Assistance

Depending on individual circumstances, refugees may be met by GENDERDOC-M staff in the city, at the airport, or at bus and train stations of a refugee is unable to travel, transportation via taxi can be arranged from their current location directly to the shelter.
